Herein referred to as the property, subject to the following terms and conditions:

- Terms of Rental:** This Rental shall commence on the date of arrival to the Customer and shall terminate one (1) day before the CDC receives the property. If not returned within the terms of this agreement, Customer agrees to reimburse CDC for the above stated replacement value upon receipt of invoice.
- Acceptance:** Acceptance of the property by Customer shall constitute acknowledgement and agreement that the property was received in the condition above described. Delivery of the property shall be made to Customer at the address provided.
- Safekeeping and Maintenance:** Customer shall exercise due care for the safekeeping and maintenance of the property so that it shall not be damaged or its performance degraded, and assumes liability for loss or damage from all causes, ordinary wear and tear excepted.
- Lease Charges:** Customer guarantees payment for all lease charges as described above, including airtime, in advance by the following method: **Credit Card # xxxx-xxxx-xxxx-xxxx, exp. xx/xx.**
- Additional Charges:** Customer agrees to assume liability for any communication expense during the Rental period including but not limited to: Any charges for duties, licensing or other supplemental expense associated with use of the property.
- Network Operations:** The CDC is responsible for the performance of the rented equipment only. Satellite networks can and do experience occasional outages. CDC will not issue equipment credits for satellite network problems; the Customer agrees to address any such complaints and/or credit requests to the applicable satellite network provider.
- Redelivery of rented property:** On termination of this Rental, Customer shall redeliver the property to CDC at CDC's address or by shipping the property as CDC may direct in writing.
- Loss or Damage Liability:** Customer assumes all liability for the loss or damage of the property and the cost associated with returning property to original condition. All charges are guaranteed from Customer by: Credit Card listed in 4 above.
- Cancellation Policy:** Day-of-shipment cancellations are subject to the one-week rental minimum, regardless of whether or not the phone has been shipped. Day-of-shipment cancellations are subject to the shipping cost - but only if the shipment has already been picked up by courier. If shipment has been picked up by courier, customer is responsible for returning the shipment to CDC.
